NOTICE OF EXPRESSION OF INTEREST FOR PROVISION OF CONSULTANCY SERVICE FOR CITY TOURISM DEVELOPMENT PROJECT UTB/CONS/2020-21/00244

- 1. The Uganda Tourism Board (UTB) has allocated funds to be used for Consultancy Service for the Development and Promotion of Entebbe, Kampala and Jinja Cities as Tourism Cities. The Consultancy service will include development of product catalogues, product audit reports, tourism investment handbook, high resolution marketing videos and photos and itinerary fliers for each of the cities. The assignment will be divided into three lots and will require three different consultancy firms.
- 2. The Board now invites eligible consultants to submit sealed expressions of interest.
- 3. Interested consultants should provide information demonstrating that they are eligible and possess the required qualifications to perform the services supported with relevant documentation.
- 4. The short-listing criteria will include:
 - i. Legal documents valid trading licence or equivalent, certificate of registration/incorporation or equivalent and power of attorney.
 - ii. The firm must demonstrate proven similar experience from previous clients in the same field of expertise (provide detailed information on each of the similar assignments).
 - iii. The firm must have tourism knowledge and experience working within the tourism environment.
 - iv. The firm must provide evidence of appropriate skills/expertise among staff.
- 5. Consultants may associate with other firms in the form of a joint venture to enhance their qualifications. The form of association, where applicable, should be indicated in the Expression of Interest.
- 6. Preference schemes shall apply when evaluating Request for Proposals from the shortlisted consultants.

- 8. Sealed Expressions of Interest must be delivered to the address below at or before 10.00 AM on 28th April 2021
